Does NSW have a solar battery rebate?

From 1 July, a larger NSW VPP incentive of up to \$1,500 will remain available and can be combined with the federal rebate. The state's Solar Battery Loan program has closed. Only the federal rebate is available. The NT Home and Business Battery Scheme has reached its funding cap.

What is the WA residential battery scheme?

The WA Residential Battery Scheme allows you to access a rebate and/or a no-interest loan to purchase and install a battery to power your home. The WA Government's scheme is in addition to the Federal Government's Cheaper Home Batteries Program. On a 10kWh battery applicants are eligible for a combined rebate of:

How much is a solar battery rebate?

Minister for Climate Change and Energy Chris Bowen promoting Labor's Cheaper Home Batteries Program. How Much Is The Solar Battery Rebate Worth? At the time of the scheme's launch in 2025, the subsidy is a maximum of \$372 per kilowatt-hour (kWh) of usable battery capacity.

Who can install and upgrade multiple batteries under the solar scheme?

Only someone with several properties or who moves on to a new residence could potentially install or upgrade multiple batteries under the scheme; Installers are required to be accredited for battery installation by Solar Accreditation Australia (check your preferred installer's status here).

How will Australian government fund solar batteries?

The Australian Government will fully fund the discount for solar batteries by purchasing small-scale technology certificates (STCs). This means no costs will be passed on to householders through energy retailers. Household batteries will assist in balancing electricity supply and demand across the whole grid.

What is a solar rebate or subsidy?

A rebate or subsidy will cover part or all of the upfront cost of buying solar or a battery. Rebate schemes operated by states, territories and local governments sometimes only apply to particular groups of people or types of housing, such as social housing, rental properties or apartments. Eligibility criteria may relate to:
