

Notice on the adjustment of national energy storage pricing policy

How will China's new energy pricing policy affect the future?

“This new pricing policy will significantly accelerate the construction of a modern power system and ensure the sustainable development of renewable energy,” said Zhang Dayong, deputy secretary-general of the China Association for the Promotion of Industrial Development.

What is a new energy price settlement mechanism?

On the other hand, it provides support for wind and solar new energy through the establishment of a “New Energy Sustainable Development Price Settlement Mechanism” (referred to as the “Settlement Mechanism” or “Mechanism”) to promote the sustainable development of new energy.

What is Jiangsu's 'notice on optimizing time-of-use tariff structure?

On April 30th, the Jiangsu Provincial Development and Reform Commission officially issued the “Notice on Optimizing the Time-of-Use Tariff Structure for Industrial and Commercial Users to Promote New Energy Consumption, Reduce Enterprise Electricity Costs, and Support Economic and Social Development.”

What are the major reforms in the energy sector?

The two ministries pointed out that the reforms include three main aspects. The first is to promote the comprehensive formation of renewables feed-in tariff by the market. In principle, all power generated by renewable projects will enter the power market, and the feed-in tariff will be formed through market transactions.
