Rhode Island has a robust Renewable Energy Standard in place, but unfortunately, it currently does not have an active SREC market, so solar energy credits are not available in the area.

Does Rhode Island offer a battery incentive program?

Rhode Island offers battery incentive programs in addition to solar incentives. The Connected Solutions Program is a demand response program that compensates you for allowing RI Energy to access your battery during times of peak energy demand.

What is the solar investment tax credit in Rhode Island?

The federal solar investment tax credit (ITC) is worth up to 30% of your entire system cost in Rhode Island. It is a federal incentive available to all homeowners in the state.

Are solar panels a good investment in Rhode Island?

Solar panels can be an expensive investment in Rhode Island, but incentives from the state and federal governments can help you save thousands on the upfront cost. This makes solar panels a worthwhile investment.

Does Rhode Island offer a small scale solar grant?

Rhode Island's Small Scale Solar Grant program includes an energy storage adder, which is an additional \$2,000 credit for installing an energy storage system with your solar panels. All batteries above 3 kWh are also eligible for the 30% federal tax credit. The passage does not mention a direct grant for small scale solar systems.
