



# Solar battery rebate program

How much does a solar rebate cover?

This rebate may cover 15 percent to 100 percent of the installation. Installation includes battery storage, or solar and battery storage for residential customers only. Funding will vary by budget for specific program eligibility.

Do solar rebates work?

Several states offer rebate programs that cover some or all of the cost of purchasing a home solar system and/or battery storage. These rebates can work in addition with the federal tax credit to increase the savings of going solar. For example: Maryland offers a \$1,000 rebate for solar photovoltaic and solar shingle installations above 1 kW.

Are there incentives for home solar batteries?

As a result, there are now several incentives available for home solar batteries, including federal and state tax credits, rebates, and utility programs. Some of them come with certain requirements, like reserving battery capacity for the utilities to use, and then there are others that offer an incentive for simply purchasing a battery.

What are solar rebates & incentives?

Rebates and incentives are a crucial way to encourage broader adoption of solar energy and full home electrification across the country. These incentives will typically come from your utility, state government, or the federal government in the form of tax credits, property tax abatements, one-time rebates, or performance-based rebates.

What is the energy storage rebate program?

The program was started in 2018, as a response to the need for energy storage systems in fire-prone areas where utility companies frequently shut off power. The program currently offers rebates of between \$150 and \$1,000 per kilowatt-hour of storage.

Does Oregon have a solar & storage rebate program?

In 2020, the Oregon state government made \$10 million available for its Solar + Storage Rebate Program, which provides rebates of \$300 per kWh for residential battery systems.
