Are there incentives for home solar batteries?

As a result, there are now several incentives available for home solar batteries, including federal and state tax credits, rebates, and utility programs. Some of them come with certain requirements, like reserving battery capacity for the utilities to use, and then there are others that offer an incentive for simply purchasing a battery.

Can you get a home battery subsidy if you're a small business?

In addition to homes, the subsidy is also available to small businesses and community facilities. The scheme is uncapped, which means there's no limit on the number of subsidies available. Do you qualify for a solar subsidy?

However, there are subsidy schemes available in different states and territories, as well as some local government areas, to help with the upfront cost of installing solar and batteries. These are in addition to STCs. Depending on where you live, you might qualify for: a rebate swap, where you receive a solar subsidy instead of bill rebates.

Do solar batteries qualify for a tax credit?

Luckily, batteries also qualify for the tax credit, whether or not they're installed with solar panels. Before 2022, a battery storage system had to charge exclusively from solar energy to qualify for the tax credit. Then Congress passed the Inflation Reduction Act, which updated the tax credit to include batteries not charged from solar power.

How much does a 10 kWh solar battery cost in 2025?

So, for a home battery with a 10 kWh usable capacity, the incentive is roughly \$3,720 in 2025 and, after fees and charges, likely lowers the installation cost by around \$3,300. How much does battery subsidy cost?

At the time of the scheme's launch in 2025, the subsidy is a maximum of \$372 per kilowatt-hour (kWh) of usable battery capacity. After administrative fees and charges, the actual battery price reduction is likely to be around \$330 per usable kWh.
